**IN HIMACHAL PRADESH, INDIA**

1. This invitation for bids follows the general procurement notice for this project that appeared in the newspapers of India.
2. Bidding is open to all bidders from eligible source countries as defined in the IBRD (International Bank of reconstruction and Development) Guidelines for Procurement. Bidders from India should, however, be registered with the Government of Himachal Pradesh/Other State Governments/Central Government/Government Undertakings. Bidders are advised to note the qualification criteria specified below.
3. M/s Bharmour Hydro Projects Pvt. Ltd. herein after called the “Employer” now invites sealed bids from eligible Bidders for “**Package – I; Civil and Hydro Mechanical works for BHEP – I**” (herein after called the “Project”) in Chamba, Himachal Pradesh, India.
4. Bidding will be conducted through the International Competitive Bidding (ICB) procedures and is open to all bidders from eligible source countries as defined in the guidelines.
5. A two-envelope International Competitive Bidding (ICB) procedure will be adopted. Bidders are to submit simultaneously two sealed envelopes, one containing the Techno-Commercial proposal and the other containing the Price proposal. Initially only the Techno- Commercial proposals will be opened. Techno-Commercial proposals which are submitted by non-qualified bidders or which are not substantially responsive will be rejected. The financial bids will be opened for technically qualified bidder only.
6. Interested eligible bidders may obtain further information from the Employer and inspect the bidding documents in their office address given below on all the working days from 10:00 Hrs to 18:00 Hrs.
7. A complete set of bidding documents in English may be purchased by the interested bidders starting from the date specified below on submission of a written application and upon payment of a non-refundable fee specified below in the form of Demand Draft in favour of Bharmour Hydro Projects Pvt. Ltd. payable at Hyderabad.
8. Techno-Commercial bid will be opened on 45<sup>th</sup> day (08.08.15) around 15:00 hrs from the start date of sale of bid document in the presence of Bidder’s representatives who choose to attend on the specified date and time. In the event of the date being declared

as a closed holiday for Employer's office, the due date for submission of bids and opening of bids will be the following working day at the appointed times.

9. The Employer will not be responsible for any costs or expenses incurred by Bidders in connection with preparation or delivery of Bids.
10. The Employer reserves the right to reject any or all bids or cancel/withdraw the invitation for Bids without assigning any reason whatsoever and in such case no bidder/intending bidder shall have any claim arising out of such action.
11. The Project completion schedule is 24 months from date of award.

#### **Qualification Criteria:**

1. The bidders (sole/ consortium) must have experience in scope of works (in hydropower projects specially in Himalayan terrain) should have completed or substantially completed at least one project of **75 Crores** (Rupees Seventy Five Crores only) worth out of which minimum Civil works worth of 60 Crs. and H&M works worth of 15 Crs. should be required or 10 MW capacity of similar terrain project should be completed or reached in completion stage in last 3 years period which is in successful operation or reached operation stage.
2. The average annual turnover of Bidder in the preceding three (3) financial years as on the date of bid opening, shall not be less than **INR 50 Crores** (Rupees Fifty Crores only) Financial reports such as audited profit and loss accounts, balance sheets, auditor's report, banker's certificate are to be submitted to substantiate the financial strength

3. Bidder has necessary financial stability and status to meet the financial obligation pursuant to the works covered in the bidding documents. Bidder shall submit the three (3) copies of their profit and loss account and balance sheet for the last five (5) years.
4. The units/systems/equipments referred by bidder should be in successful operation for the last one (1) years and bidder should be able to produce completion certificate for the same by end user.
5. Bidder shall submit proof of qualifying requirements, in the form of reference lists, performance letters from customers, etc.
